**Description:** By focusing on examples from Dubrovnik and Slavonia, this panel examines Italo-Croatian exchanges in the Medieval period, highlighting the relevance of Adriatic worlds in pre-modern Europe. The didactic value of wine, the preservation of genealogies, and the unique story of the De Surdis family offer insights into these complex intellectual and political networks.

**Description:** This panel examines “bottom-up” memories in contemporary Italy through unconventional sources, informal practices, and hybrid subjectivities. Bringing together studies of private and community archives, migration narratives, amateur cinema, oral histories, street art, and marginalized testimonies, the panel foregrounds how affect, cultural consumption, and participation shape collective memory beyond institutional frameworks. Across analog and digital media, the contributions explore how memory emerges in liminal spaces—between private and public, silence and narration, resistance and consumption—revealing polyphonic, contested, and often overlooked modes through which Italian memory and identity have been produced over the past century.

**Description:** Photography has long shaped how reality is seen, understood, and contested. Beyond representation, it operates as a visual regime that renders bodies, movement, desire, and violence legible while structuring relations of power and knowledge. This panel examines photography as a site of aesthetic experimentation, cultural mediation,

and political intervention, exploring how images negotiate realism and abstraction, visibility and opacity, and normativity and dissent. Bringing together historical and contemporary perspectives, this panel considers how photographic practices frame social experience, challenge dominant visual narratives, and open critical spaces for rethinking identity, embodiment, and authority.

#### Literature of Imprisonment from the Renaissance to the Present

**Description:** The panel examines literary works that, from the Renaissance to the present, have accompanied the emergence and consolidation of practices of confinement across diverse socio-anthropological and institutional contexts. Its aim is to investigate literature’s contribution to the modern and contemporary imaginary of confinement, identifying long-term continuities and key turning points in its historical evolution. The contributions deploy a broad methodological toolkit to foreground the multiple referential and metaphorical resources of literary writing, showing how literature not only reflects historical realities but also imaginatively articulates narrative models, moral frameworks, spatial logics, and anthropological assumptions underpinning practices of imprisonment.

**Description:** This panel addresses the shifting landscape of contested memorialisations of Italian history in Italy and the United States, mapping new forms of memory work that both reinforce triumphalist narratives of empire and, conversely, localised practices that seek to recontextualize dominant narratives of settler colonialism and imperial violence. These papers engage a transnational framework of enquiry that connects disparate sites of contemporary memory work and contestation.

**Description:** This panel invites papers that reconsider Pier Paolo Pasolini's contributions as a theorist—within film theory and across broader cultural discourse—and that explore how his multidisciplinary oeuvre has itself come to function as theory. Despite Pasolini's canonical status in Italian Studies, his film theory remains insufficiently examined. Following the publication of *Empirismo eretico* (1972), semioticians such as Umberto Eco and Christian Metz challenged his destabilization of structuralist distinctions between nature and culture. From the late 1980s onward, scholars including Giuliana Bruno and Teresa de Lauretis revisited Pasolini from poststructuralist perspectives, reading his emphasis on gesture and embodiment as a challenge to linguistic models of cinema. Yet these engagements remain fragmentary, and the broader implications of Pasolini's theoretical interventions have not been fully explored. Addressing this critical lacuna, the panel also asks how Pasolini—his writings, films, thought, and even persona—has come to operate as theory: a conceptual figure or "thought object" through which contemporary debates, methodologies, and modes of critique are articulated.

**Description:** As a peninsula that juts into the sea and is crisscrossed by more than a thousand rivers, Italy is a country inextricably linked to water. Within the framework of the Blue Humanities (Neimanis 2017; Opperman 2022; Jue 2021; Helmreich 2023; Mentz 2024; Alaimo 2025), this panel examines water’s materiality and the various forms through which it is mediated—and, in turn, mediates—specific Italian environments. **Description:** This first session of three panels explores Italian radical contestation from unification to the present, be it in the form of an individual rebellion, a short-lived local revolt, or widespread decades-long activism. We investigate radical contestation in which individuals questioned the very roots, moral/ideological frameworks, or social/economic/political structures of society. What ideas, events, actors, and processes of Italian radical contestation remain understudied and/or little known? What forms of backlash has radical contestation faced, and to what extent was it able to change the very roots of society? How has radical contestation been retold and how might we add to or challenge these narratives?

**Description:** This panel reexamines the family novel beyond narrowly defined generic frameworks centered on genealogy, continuity, and tradition. Focusing on the Italian literary context, it explores how the genre has negotiated temporality, kinship, and power, while adapting to social and cultural change. Drawing on postcolonial, diasporic, ecocritical, and care-centered perspectives, the panel highlights alternative configurations of family, community, and relationality that challenge conservative readings of the genre. It argues for more fluid and inclusive models of the family novel, capable of fostering equity, community formation, and emancipatory visions of kinship.

Travers examines medieval vernacular poetry and geography to show how mainland Italian writers imagined Sardinia as a nexus of Mediterranean exchange and a moralized warning about maritime ambition. Coleman traces 15th and 16th century *isolari* to reconstruct premodern pathways of information circulation linking Italian and Ottoman worlds through composite cartographic-literary forms. Daniele turns to 17th century court spectacle, arguing that staged islands such as Trinidad and Cyprus operated as premodern epistemic devices—bounded spaces where sovereignty and territorial desire could be visualized and tested in performance.

**Description:** When we use the words “orthodox” and “heterodox,” we usually think of a religious context, as was the case with Richard Pecoock around 1454 in his text, *The Follower of the Donet*. However, in the seventeenth century, the use of both terms was extended to mean, respectively, “in accordance with views, attitudes, beliefs, or practices prevalent or established in a particular society, field, profession, party, etc.; conventional,” and “the quality or character of being heterodox; deviation from what is considered to be orthodox.” (*OED*) With this roundtable, we aim to explore a broader cultural spectrum of the terms “orthodox” and “heterodox,” which are not limited to the religious sphere but also extend to the political, philosophical/intellectual, and medical spheres. Dmitri Levitin has recently pointed out that the portrait of orthodoxy should not be seen as a monolithic entity, but rather as a pluralistic and complex one. He also argued that the condemnation of heterodoxies was not the result of the all-seeing panopticon, but of local political and ideological conflicts. Since both terms are connected to belief systems, we can also say that as beliefs change over time, the heterodoxies of one period may become the orthodoxy of the next.

It explores how genre conventions, media spectacle, and narrative framing operate as mechanisms of both visibility and control, especially in relation to female representation and cultural trauma. Italian film, television, and digital platforms have emerged as critical spaces where the nation negotiates instability, reimagines care, and stages new ethical and emotional responses to crisis. Contemporary screen narratives simultaneously revisit the past and interrogate the precarities of the present, offering viewers nuanced ways of understanding what it means to live—and to care—within fractured social, political, and affective landscapes. The film is thus both a cinematic and ethnographic journey, revealing the invisible threads that connect myth, landscape, and living folklore across time. *Anime galleggianti* is considered part of the *cinema dell'anima* movement, as coined by Cavallo and explored alongside scholars Federico Pacchioni and Russell Kilbourn in their forthcoming volume *Cinema dell'anima: A New Shared Vision in Italian Cinema*. **Description:** When we use the words “orthodox” and “heterodox,” we usually think of a religious context, as was the case with Richard Pecoock around 1454 in his text, *The Follower of the Donet*. However, in the seventeenth century, the use of both terms was extended to mean, respectively, “in accordance with views, attitudes, beliefs, or practices prevalent or established in a particular society, field, profession, party, etc.; conventional,” and “the quality or character of being heterodox; deviation from what is considered to be orthodox.” (*OED*) With this roundtable, we aim to explore a broader cultural spectrum of the terms “orthodox” and “heterodox,” which are not limited to the religious sphere but also extend to the political, philosophical/intellectual, and medical spheres. Dmitri Levitin has recently pointed out that the portrait of orthodoxy should not be seen as a monolithic entity, but rather as a pluralistic and complex one. He also argued that the condemnation of heterodoxies was not the result of the all-seeing panopticon, but of local political and ideological conflicts. Since both terms are connected to belief systems, we can also say that as beliefs change over time, the heterodoxies of one period may become the orthodoxy of the next.
